FUNDRAISER CASE STUDY: 100k Peak District Ultra Challenge Raised £1,722.50

Step 1 - Make a plan

Ask yourself.....

- Have I set a target amount to raise and a date to achieve it?
- Can I utilise any skills or talents?
- Who do I know who could help me (e.g. with sponsorship goods, services or prizes)?
- Am I going to organise or take part in an event or series of events?
- Who is my target audience and have I allowed enough time for planning and preparation?
- Could your employer possibly match fund your efforts?

Step 2 - Create an online sponsorship page

To make collecting money easier, BOSP recommends setting up a free online sponsorship page at https://www.givey.com or Just Giving.

Pages are simple to set up and all donations are sent to BOSP automatically, saving you the trouble of dealing with cash.

Tips for a successful fundraising page include:

- Make it personal. If you have a special reason for supporting BOSP, please share it on your page. Add pictures and information about BOSP so that people understand why they are supporting you. Please contact BOSP if you would like help writing your page
- Show your fundraising target on the page. Be ambitious, as pages with high fundraising targets raise more than those without. You can also increase the amount you plan to raise as you get closer to your target

Step 3 - Let everyone know!

Once you have decided what you want to do and when, tell everyone you know! You will be amazed how generous people can be when you are passionate about why you are raising money for BOSP.

- Use your network to raise funds; family, friends and colleagues at work, the pub, the gym, your church, school or social club may all be willing to support you
- Contact local businesses to see if they can help with things like raffle prizes or the use of free space for events. BOSP can provide an official letter confirming that you are fundraising for the Charity
- Share your plans and details of your online fundraising page via your blog, email signature, Facebook, Instagram, Linked In and other social media! It's a great way to keep your family and friends updated on your progress too!
- Recruit a team of friends and family to help fundraise on your behalf

Step 4 - Get noticed

- Local newspapers and radio stations are always interested in positive community stories, so if you are organising an event, or doing something particularly remarkable to raise funds, why not get in touch to let them know? BOSP can help you with guidelines on writing a press release and preparing for a short radio interview
- Make use of BOSP promotional materials. We can provide posters, leaflets and other items should you need them
- On the day itself, remember to take some pictures to share with BOSP and your supporters after the event

Cash - You can bring to us at The BOSP Office during office hours. Please do not send cash to BOSP in the post.

Paper Sponsorship Forms - You can pay the money in using any of the above methods but please do send us the paper forms - we need them to be able to claim Gift Aid.

Online Fundraising Pages - All funds raised through online fundraising pages will have been automatically transferred to BOSP, you do not need to worry about that!

Gift Aid it! - Gift Aid is a government scheme which enables charities to claim 25% on top of any donation made by individuals who pay Income Tax. Please encourage people to Gift Aid their donations and boost your fundraising total! If you are sending a personal cheque or donating money to BOSP via BACS, please let us know that you would like to Gift Aid your donation.
